



# Financial Aid Data Collection 2024 – 2025 Aid Year Release of Version 1.5

On September 22, 2025, Information Technology Services (ITS) released Financial Aid Data Collection Version 1.5 for the Financial Aid Data Collection (FADC) 2024 – 2025 Aid Year. This collection is scheduled to open on **October 9, 2025**.

ITS would like to thank Georgia Gwinnett College, Kennesaw State University, the University of Georgia, and the University of West Georgia for beta testing this release.

## **COLLECTION PREREQUISITES:**

- Financial Aid Data Collection Version 1.5 must be installed in your Banner environment.
- Institutions must run the Banner FISAP process for 2025 award year (RORFS25) prior to extracting for the 2024 - 2025 collection.
