**Information about Proposed Data Element**

1. Name of existing data element:

Regents Academic Interest Code: Request for a new valid value for programs leading to initial teacher certification.

2. Why is the change needed?

*There is a critical teacher shortage in Georgia that has persisted for years. Current coding of student majors/concentrations does not allow for the easy identification of which students are in programs that lead to teacher certification. Some examples of complications:*

- *Not all baccalaureate programs with a “13” Education CIP code lead to teacher certification.*
- *For programs that lead to secondary teacher certification at the undergraduate level, they are often coded as a concentration within a Bachelor’s degree in the content area (e.g., BS Math). In those instances, not everyone in the major is in a teacher certification program, only students in one concentration are.*
- *At the graduate level, MAT programs typically all lead to initial teacher certification, but there are examples across the state of MED and EDS programs that also lead to initial teacher certification.*

*Without good tracking mechanisms, it is challenging to determine what progress we are making on addressing the teacher shortage.*

*Institutions will continue to use existing program/major/concentration codes for all programs leading to initial teacher certification (most institutions will have multiple programs). However, those existing PROGRAM CODES & INST MAJOR CODES codes will need to be cross walked on Banner administrative form SOAXREF, under the RGTACIN cross-reference label, to the new value of “ZITC” for data collection purposes.*

*This process will allow for the following mappings:*

*PROGRAM\_CODE to ZITC*

*INST\_MAJOR\_CODE (Associated with FOS\_CATEGORY (field of study) of MAJOR, MINOR, or CONCENTRATION) to ZITC*

*PROGRAM\_CODES & INST\_MAJOR\_CODES translated to ZITC will continue to be collected. The translated value of 'ZITC' will be stored in a new and separate field in the USG database tables after collection.*

*This is the same process used for the Nursing Interest Concentration of 'ZNUI'*

6. Where is the data element currently collected in Banner (table and form)? Would the proposed change also be in the same Banner table and form? If not, please explain.

*Banner Tables: SORLFOS (SOVCFOS).*

*Banner Forms: STVMAJR – creation of code*

*SOAXREF>RGTACIN – translation of code*

*ZITC concentration code should not be present on SHADEGR records, nor will the crosswalk/translation be performed on SHADEGR records.*

7. To what other existing USG data elements is this one related and how would the new element affect them? Provide rules/edits that should be followed in collecting this information.

*Confirmed 'ZITC' does not exist in the inst\_major\_code field for any institution as of 5/28/2025*

*No validation is needed for this code; it can be applied to majors used by both undergraduate and graduate students.*
